Enjoy California's Premier Horse Camp where you will feel like you're miles away from it all - only 40 minutes from Woodside! Ride to your heart's content and then relax with a beverage and a fabulous catered meal. Dance the night away on Saturday night to live music under the stars!

SMCHA has reserved the Horse Camp from Wednesday, July 25, beginning at 3 pm until Monday, July 30 noon.

Campsite No. 1 will be available after 3pm on Wednesday, July 25 until Monday, July 30 noon.

Campsites No. 2 & 3 will be available after 3pm on Friday, July 27, until Sunday, July 29 noon.

Cost: CATERED Friday night dinner through Sunday lunch (6 meals), includes beverages and camping fees for Fri and Sat nights *sorry, no partials*

Members: \$190 pp, Non-Members: \$225 pp (join SMCHA ahead of time and save!)

Camping fees for Wednesday, Thursday and Sunday nights (BYO Food/Bevs):

Members: Adult \$25 per night 13 and under \$15 per night

Non-Members: Adult \$35 per night 13 and under \$20 per night

Saturday Night (only) Dinner and Live Music: \$40 pp. There will be a raffle and Silent Auction, followed by dinner - the fun starts at 5:30pm!

Riders under 18 **MUST** wear helmets & boots and their horses **MUST** be ridden using a saddle & bridle. SMCHA recommends all adults ride with saddles, bridles/hackamores. No Stallions,dogs or other pets allowed. Please RSVP by July 19; after that add \$25 per person.

Directions to Jack Brook Horse Camp

Highway 84 from Woodside through La Honda. Turn left at Pescadero Road, travel past Sam McDonald Park, go one mile to Horse Camp entrance on left, watch for Horse Camp sign on right side of road just before the camp road gate. Be aware of the entrance/exit rule and timetable (See Note Below). Suggestion to newcomers: some people unload at the Sam McDonald parking lot and pony their horses up to the camp and drive truck & trailer into the camp empty because of the road grades. Also, be prepared to take a different route if Highway 84 between Woodside and Skylonda Corners is under construction. Take Highway 92 to Highway 35 (Skyline Blvd.) to Highway 84, turn right and go west to La Honda, etc.

ENTRANCE & EXIT POLICY FOR JACK BROOK HORSE CAMP

IMPORTANT INFORMATION--PLEASE READ

The road into the horse camp from Pescadero Road is **NARROW, ONE WAY** (in most places), and has **NO TURNOUTS**. There is no room to pass another truck and trailer. For the safety of you and your horses, the following time restrictions are mandatory and will be strictly enforced:

For ALL incoming traffic (Entering the horse camp)
Drive in on the hour until "20 minutes after the hour"
Example: 10:00 a.m. - 10:20 a.m. or 2:00 p.m. - 2:20 p.m.

For ALL outgoing traffic (Leaving the horse camp)
Drive out on the half-hour until "10 minutes to the hour"
Example: 3:30 p.m. - 3:50 p.m. or 5:30 p.m. - 5:50 p.m.

Drivers not in the correct time slot will be obligated to back up, and may be cited by park staff.

Drive time is approximately 10 minutes.

There is a waiting area just past the camp entrance on the left on Pescadero Road, or pull into Sam MacDonald Park Parking lot to wait.

USE CAUTION AT ALL TIMES! EMERGENCY OR URGENT SITUATIONS MAY OCCUR THAT WILL NECESSITATE PARK STAFF OR EMERGENCY PERSONNEL TO USE THE ROAD IN CONFLICT WITH THE ABOVE SPECIFIED TRAFFIC POLICY. ALWAYS YIELD TO EMERGENCY VEHICLES AND SAFELY FOLLOW THE PARK STAFF OR EMERGENCY PERSONNEL'S DIRECTIONS.
